PRIVACY POLICY

INFORMATION GATHERED BY YO NEIGHBOR!

This is Yo Neighbor!'s ("Yo Neighbor!") online privacy policy ("Policy"). This policy applies only to activities Yo Neighbor! engages in on its App and does not apply to Yo Neighbor! activities that are "offline" or unrelated to the App.
